### Web scraping data on rural housing in Sweden

Web scraping is a method for mechanically gathering data from webpages. It entails utilizing software to extract data from online pages, including text, photos, and tables. Web scraping can be used to collect pertinent information about farming, the weather, nearby events, or community services in rural locations. This information can be examined to comprehend rural patterns, keep track of environmental changes, or evaluate the resources that are available in various areas. # Towards a GRANULAR territorial typology for rural diversity




