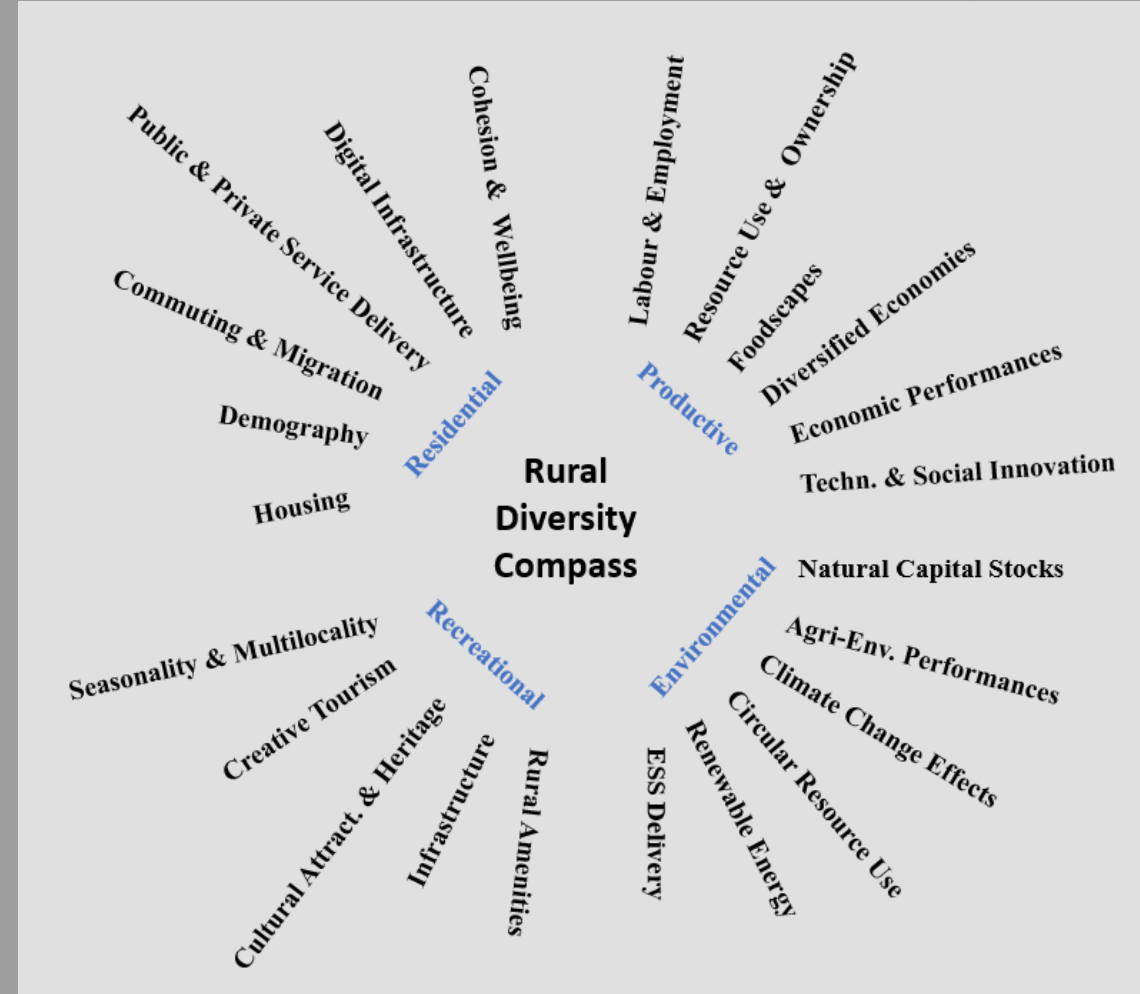
Prototype Rural Diversity Compass: Multi-Functionality Characterization with the help of 24 Components

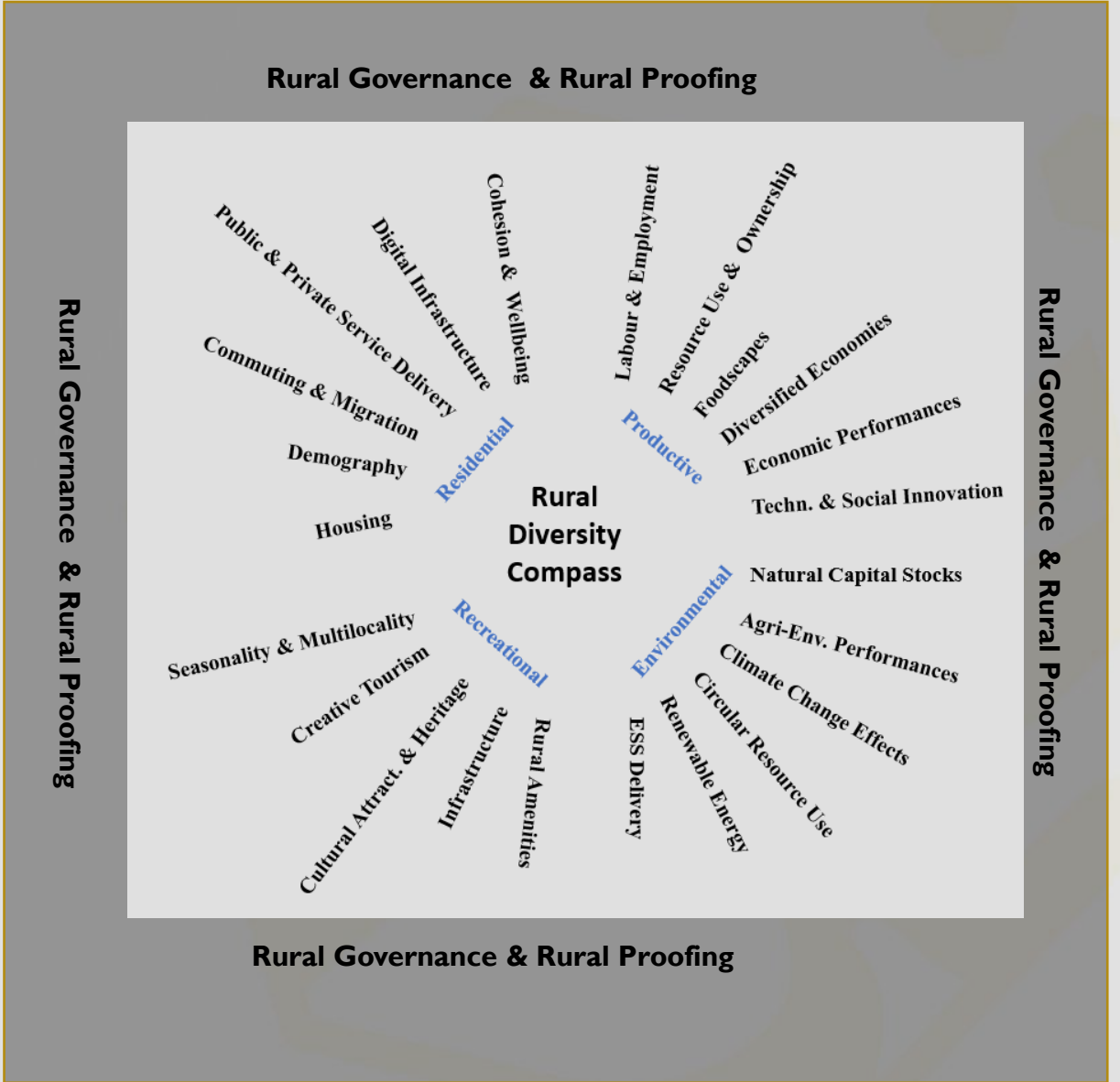

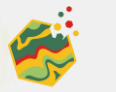

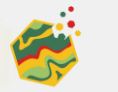
EMPIRICAL ILLUSTRATION BY DUTCH LIVING LAB SETTING

- Prototype Compass tool that enables to:
 - social- spatial- and climate justice issues and controversies;
- Address and specify wellbeing needs and wellbeing contributions of Dutch most rural municipalities;
- Place these in a wider context of manifold claims on scarce rural land resources;
- Explain its accompanying
 - Specify national wider policy questions / dilemmas;



NATIONAL RURAL POLICY MAKING DILEMMAS

- Which aspirations re global food security contributions?
- Which role for animal production in sustainable food systems?
- Landsparing or Landsharing as basis for rural spatial planning?
- Supra-national exchange of policy objectives or not?
- Further interventions in consumer behaviour policy acceptable / necessary or not?



IN CONCLUSION:

- GRANULAR's Prototype Rural Diversity Compass: Analytical tool for a better understanding of rural functionality dynamics, drivers and outcomes;
- Supportive tool to characterize the place-specificity of contemporary rural governance and rural proofing challenges (i.e. accommodating rural diversity instead of focussing on urban-rural disparities)
- To be further tested and validated through ongoing and forthcoming GRANULAR activity
